## **COLLECTION AND USE OF PERSONAL INFORMATION**

Tri-County Concerts' website's registration forms ask users to provide us with contact information such as name, physical address, phone number, and email address. An email address must be provided if a user wants to receive our newsletters. Our donation and advertising forms also request contact information. Users purchasing concert tickets and donors and advertisers submitting payments online must provide contact information for their payments to be processed, but can also purchase tickets at the door or make a donation or payment by check. Tri-County Concerts uses contact information submitted to us or to payment processors to fulfill orders and to send audience members and friends information about us and our programs and services. Contact information may also be used on occasion to contact individuals.

Payment data including contact and credit card information is collected by third party providers when a user chooses to purchase concert tickets or make a donation or advertising payment online. Tri-County Concerts does not receive payment data other than contact information and is not responsible for the privacy practices of such third party providers.

## **OTHER INFORMATION GATHERED BY TRI-COUNTY CONCERTS**

For some newsletters and other communications distributed by Tri-County Concerts or materials available on our website, specific information on recipient or user responses is collected. For example, we may review how many and which recipients or users open and click through to links provided within a newsletter or on our site. We use this information only for the purposes of analyzing areas of interest, improving our programs and services, and enhancing the usefulness of our communications and site. None of the information is sold, rented, or shared with anyone outside Tri-County Concerts for any other purpose.
